# Youthlaw's Services

#### **Affirmative Consent Education**

A community legal education initiative focused on empowering young people by providing them with the knowledge and support they need to understand affirmative consent.

#### **Community Legal Education**

Community legal education clinics that take place in various locations in Victoria, the clinics cater to both young people and workers within the youth system.

### **Friday Fines Clinic**

Advocates for and provides legal assistance to young people with fines, debts and infringements. The clinic is available every Friday, please call first on (03) 9113 9500.

## **Frontyard Clinic**

Youthlaw provides a legal assistance service for residents of Melbourne City Mission and Frontyard. The clinics are available every Tuesday and Thursday 2pm - 5pm.

#### **Family Violence Program**

An integrated practice between lawyers and social workers to provide comprehensive support to young people using and experiencing family violence. This program also provides Duty Lawyer services at Children's Courts in the inner urban and northwestern regions.

## Family Violence Program (AVITH)

The Pre-court Support for Adolescents
Using Violence in The
Home (AVITH) facilitates early referrals,
legal advice, representation and social work
support focusing on young people under 18
using family violence and subject to
intervention order
proceedings.

#### **Legal Pod Program**

Connects young people with a small team of pro bono lawyers from private firms (legal pod) to provide long-term legal support for up to three years. The aim is to assist vulnerable young people as they transition from out-of-home care.

#### **Outreach Services**

Working in partnership with 16 mental health, learning, housing, and detox organisations who are engaged with young people. Youthlaw conducts weekly site visits and additional visits as necessary to offer legal consultations, representation, and educational support. For further information contact (03) 9113 9500.

#### Youthlaw Ballarat

An integrated service within Ballarat Community Health, providing young people in the Central Highlands access to specialised legal services.
